Budget Amendments

Carolyn McCain recommendation to approve budget amendment to reclassify the current HR Business Partner, Workforce Development position to Manager, Talent Acquisition & Workforce Development, effective August 1, 2026. The financial impact in 2026 budget year will be \$7,548.67.

Winfried Danke recommendation is to increase the 2026 operating budget by \$14,835 in salaries and \$4,451 in benefits for a total of \$19,286 to increase a primary care ARNP same-day provider position from 0.8FTE to 1.0 FTE to support Mason Health's Access to Care improvement strategy. Annualized, this FTE expansion will cost \$29,670 in additional salaries and \$8,901 in additional benefits for a total of \$38,571 a year.
